**Registration Fee: \$85.00 per child; This is payable with completed application. Registration is non-refundable.** \_\_\_\_\_

### Basic Rates and payment policies

- Session tuition is \$195.00 per week, (per child)

### Pick up Policy

All participants must be picked up by 3:30 PM unless he/she is participating in karate class program. If your child has not been picked up by 3:30 PM an additional \$20.00 will be charged. If a parent is more than thirty minutes late an additional \$10 (or a total of \$30.00) will be charged. Late charge is per child, per incident. \_\_\_\_\_

### **Policies & fees regarding Absences, holidays, vacation and extended care.**

NO credits or refunds for absences. Payment shall be expected for all days that the child is enrolled.

### Termination Procedure

Either party may terminate this agreement upon providing two weeks written notification. Note that two weeks' notice refers to calendar weeks.
